Being concerned by all of these unprecedented decisions on Praghosa's part a council meeting is called which Praghosa refuses to attend and instead sends a letter to be read by the chairman indicating that he has resigned from all managerial responsibility for the yatra, including that of GBC. Janmastami on the request of the committee writes a summary of the events to date and submits them to the committee and also to the GBC body due to the seriousness of a GBC resigning without notice.	That further discussions take place and that a thoughtful decision is reached as to whether Praghosa wishes to continue on as GBC, a role that every member of the committee has been up until this point enthusiastic that he does hold however that he has indicated on a number of occasions and in writing that he does not wish to hold. Supervision by the Euro RGB or another GBC approved independent body would also be appropriate considering the resignation from the GBC role and the lack of knowledge by local devotees of the mechanics of a GBC's resigning suddenly without notice.	An email is sent to Janmastami on the day of the Janmastami festival whilst he is away in the States written in Praghosa's style of writing but without his signature but instead with the other committee members names attached stating that Janmastami is offensive and as such has been removed from the roles involving managing the temple, Rathayatra and communications. Upon investigating this further it transpires that these devotees did not agree to add their names to this email, but instead to a much milder draft of the email which encourages dialogue. They later apologise that any email was sent at all and it is stated that they only agreed to it because they were threatened that if they did not sign it Praghosa's resignation would stand but that he would withdraw his resignation and not put his services on them if they agreed to sign it.
Upon Janmastami's return Praghosa continues to refuse to meet so a group of devotees considered impartial are called in to investigate what is taking place and express their opinion. At a meeting that takes place they state that Janmastami should be reinstated as manager of the temple and that it was wrong that he had been removed and also that the concerns regarding Praghosa would be investigated.	That this is acted upon.	After the meeting a few days pass with no contact, then a letter is given to Janmastami restating what has been said in the meeting that the management positions should be reinstated. This is understood by Janmastami to have been circulated to everyone involved due to it being an official statement. Janmastami responds to those involved appreciating their decision that he should be reinstated but emphasising that the priority is on resolving whether or not Praghosa is serving in his roles. Soon after though it emerges that Praghosa is 'upset' by the letter and it is withdrawn.

They all agree that they want the project's to succeed and they present to Janmastami a letter asking him to step down from his present responsibilities and pass over control to Syamananda. Janmastami agrees with the practicalities of Syamananda being in charge but not the principle of removing someone when what they did was merely try to manage as best they could the more dramatic challenges that were placed upon them by their GBC whilst in the admission of the letter presented by the Council the roles were 'dutifully maintained'
Presently, there has been a lot of fragmentation in the community because of this and these difficulties are a disruption to the successful running of the yatra	That Praghosa meets with all parties and apologises for his handling of the matter and for pressurising the devotees involved. That he either agrees with Janmastami's points and takes them on board or disagrees with them but values them and Janmastami's motivation as Director in keeping the yatra afloat in difficult circumstances.  That guidelines are issues by the GBC for appropriate norms of behaviour in matters like this and in situations where they are contravened that an impartial investigation takes place by a senior and impartial ISKCON manager or department for this purpose.  That everyone involved may continue to focus on their Krishna Consciousness
